CONSUELO CORRADI, Ph.D., is a Professor of sociology and Pro-Vice Chancellor for Research at Lumsa University (Rome, Italy). In 2010–12, she was the principal investigator of the national study on violence in close proximity funded by the Italian Ministry of Research. She is currently Vice-Chair of the Cost Action “Femicide across Europe”. Her main areas of research are femicide prevention, including intimate partner homicide, and the cross-national analysis of policy development in the field of violence against women. She has held visiting scholarship positions at Brandeis University (USA), East London University (UK), Université Paris-8 Vincennes-Saint Denis (France) and Universidade Nova de Lisboa (Portugal).

FABIO PIACENTI, graduate in Sociology and Educational Sciences, is the Chairman of the Independent Institute of Economic and Social Research EURES, which he founded in 1998. An expert in the qualitative and quantitative analyses she has worked as a consultant at several Italian research institutes. Since 2008, he teaches Judicial Statistics at the Master in Forensic Science from the University of Rome “La Sapienza”, performing seminars at the University of Rome, Naples and Chieti. As a star homicidal phenomenon in Italy, particularly in the interpersonal sphere, he has published numerous articles and participated in the drafting of several books on the homicidal phenomenon. He is editor of the Report on the Intentional Murder in Italy (edition from 1996 to 2013), carried out by the EURES co-operation in the Central Directorate of the Criminal Police - Criminal Analysis Service of the Ministry of the Interior and the Master in Forensic Sciences of the University of Rome “La Sapienza”. He designed and developed a specific database on intentional homicide in Italy, analyzing every homicide through a spectrum of over 250 variables, according to the context, the victims, the perpetrators, the M.O., and the legal trials, accredited in Italy and in many international studies, as one of the most authoritative statistical sources of interpretation of the phenomenon.

VALENTINA MILENKOVA is Professor, Dr.Habil. at Sociology Department, South-West University in Blagoevgrad, where she teaches the courses “Sociology of Education”, “Social inequalities and Stratification”.

She has published eight monographs and about 90 articles in Bulgarian and foreign languages. Her main interests pertain to social mobility, significance of education, educational policies and ethnic minorities.

JOSEPH LIVNI graduated the Technion, Israel Institute of Technology. In 1972 he was awarded a B. Sc. in Mechanical Engineering. In 1986 he obtained an M. Sc. degree in Engineering from the University of Tel Aviv, Israel. For many years his interests lay in Aerospace Engineering and he researched problems related to emergency landing and to vibration of aircraft systems using mathematical models and laboratory tests. In 2007 his interests sharply turned towards applying mathematical models for the study of social topics. This relatively new interdisciplinary trend takes advantage of analogies between natural and social phenomena such as spread and prevention of lawbreaking which are analogous to spread and control of infectious diseases. Together with Professor Lewi Stone of the University of Tel Aviv, he had applied a mathematical model to extract conditions of equilibrium and stability of a relatively rare type of society, namely the covenantal society. The study of justice administration in the covenantal society of ancient Israel led to searching for other existing covenantal societies. Surprisingly, works of Romanian sociologists such as Stahl, Gusti and Bădescu convinced Livni that a perfect copy of such a society has existed for

hundreds of years in Romania. An article in RJSS is a result of that unexpected revelation. Livni is affiliated with the Canadian company Omega-n, Aviation, Science and Arts.

DIANA PIȘCĂRAC graduated from the Faculty of Foreign Languages and Literatures and the Faculty of Journalism and Communication Studies- University of Bucharest, then completed a Master's Degree in Canadian Cultural Studies with a thesis on the Korean diaspora in Canada. Her interest in East Asian cultures started while still an undergraduate, at a crossroads of Japanese tea ceremony, Chinese characters and Korean independent cinema. In February 2015, she joined the KF Global E-School Project in Eurasia e-courses at the Faculty of Sociology, University of Bucharest, while trying to improve her Korean language skills at the Department of Asian Studies, Romanian-American University. Her research interests include media and cultural studies, digital cultures, education and identity politics.
