

## THE AUTHORS

**Cristina DÂMBOEANU** is a senior researcher at the Institute of Sociology of Romanian Academy since October 2001. She has a master's degree in Communication and Public Opinion at the University of Bucharest and a PhD in Sociology at the same University. She has 18 years of experience in scientific research in the fields of sociology of social problems, sociology of human rights, crime and imprisonment in a European perspective. She has a keen knowledge of quantitative research methodology, including sampling procedures, instruments design, data collection, management of databases, advanced statistical analyses. Her research has focused mainly on vulnerable categories of people such as: drug users, children who were victims of domestic abuse, restorative justice beneficiaries, and people deprived of liberty. She coordinated two national-funded projects and was team member of several others, both national and European.

**Anna KHALONINA** is a contractual PhD candidate in linguistics at the University of Paris, at the EDA laboratory, since 2018. In her thesis, she proposes an original methodology for the analysis of conceptual conflicts (metalinguistic polemics on a political concept) in the public sphere in Europe. By using the methods of French discourse analysis and Critical Discourse Studies, she works on the case of the concept of "citizen of the world". The question of the status of cosmopolitical discourse in contemporary societies is at the heart of this work, as well as the epistemological reflection on the functioning of "conceptual conflicts".
